1. Chure Rural Municipality has allocated funds towards the **Upgrading of Sahajpur-Aalad-Nigali Road (Ch 20+000 to Ch 26+000)** and intends to apply part of funds to cover eligible payments under the contract for **Upgrading of Sahajpur-Aalad-Nigali Road (Ch 20+000 to Ch 26+000) (IFB No:CRM/NCB/Works/01/079/080)**. Bidding is open to all eligible as per section V of bidding documents.
2. Gharheda Sub-Metropolitan City invites electronic bids from eligible bidders for the **Upgrading of Sahajpur-Aalad-Nigali Road (Ch 20+000 to Ch 26+000)** under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.
Only eligible bidders with the following key qualifications should participate in this bidding.
 - Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **NRS. 45 Million.**
 - Minimum Work experience of similar size and nature: **Construction/ Upgrading of Road Project of NRS. 12 Million excluding VAT.**
3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.

5. Bidder who choose to submit their bid electronically may download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost of bidding document (Nrs. 5,000/-) in the Project's Revenue Account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids.

6. Electronic bids must be submitted to the office **Chure Rural Municipality** through PPMO's e-GP system www.bolpatra.gov.np/egp on or before **12:00 Noon on 9th March 2023 (2079/11/25 BS)**. Bids received after this deadline will be rejected.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend at **14:00 PM on 9th March 2023 (2079/11/25 BS)** at the office of Chure Rural Municipality, Gharheda, Kailali. Bids must be valid for a period of 90 (Ninety) after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid amounting to a minimum of **Nrs. 7,50,000/-**, which shall be valid for 30 days beyond the validity period of the bid.
8. If the last date of purchasing, submission and opening falls on a government holiday, then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
