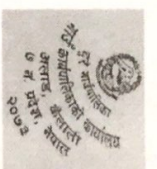

2. Under the Single Stage Two Envelope Procedure, Bidders are required to Submit Simultaneously two Separate sealed envelopes, one containing (i) The technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.
3. Eligible Bidders may obtain further information and inspect the Bidding Documents at Chure Rural Municipality Office, Gharkheda, Kailali, or may visit PPMO e-GP system www.bolpatra.gov.np/egp.

4. A complete set of Bidding Documents may be may download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost of bidding document in the Project's SanchitKosh (Revenue) account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids.

5. Pre-bid meeting shall be held at Chure Rural Municipality, Kailali at 12:00 pm on 2076/01/20 (May. 12th, 2019)

The bids will be opened in the presence of Bidders' representatives who choose to attend at 2:00 pm on 2076/01/30 (May. 13th, 2019) at the office of Chure Rural Municipality Office, Gharkheda, Kailali. Bids must be valid for a period of 90 (Ninety) after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting as specified above, which shall be valid for 30 days beyond the validity period of the bid.
7. If the last date of purchasing, submission and opening falls on a government holiday, then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
8. In case of discrepancy or error in Tender notice, bid document and other document of above projects reserves right to amend, correct at any time. Such amendment and correction shall be published in the national daily newspaper, notice board of the Chure Rural Municipality Office, Gharkheda, Kailali.
9. Hard Copy of Bid should not be obtained or submitted to Chure Rural Municipality Office.
