A complete set of Bidding Documents may be purchased from Chure Rural Municipality Office, Gharbheda, Kailali eligible Bidders on the submission of a written application, along with the *copy of company/firm registration certificate*, and upon payment of a non-refundable fee of **NRs. 3000/-** till 2076/01/29 (May. 12<sup>th</sup>, 2019) *during office hours*.

OR Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e-submission from PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp). Bidders, submitting their bid electronically, should deposit the cost of bidding document in the Project's SanchitKosh (Revenue) account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids.


4. Pre-bid meeting shall be held at Chure Rural Municipality, Kailali at 12:00 pm on 2076/01/18 (May 1<sup>st</sup>, 2019)

5. Sealed or electronic bids must be submitted to Chure Rural Municipality Office, Gharbheda, Kailali by hand/courier or through PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before 12:00 Noon on 2076/01/30 (May. 13<sup>th</sup>, 2019). Bids received after this deadline will be rejected.

6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 2:00 pm on 2076/01/30 (May. 13<sup>th</sup>, 2019) at the office of Chure Rural Municipality Office, Gharbheda, Kailali. Bids must be valid for a period of 90 (Ninety) after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting as specified above, which shall be valid for 30 days beyond the validity period of the bid.

7. If the last date of purchasing, submission and opening falls on a government holiday, then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.

8. In case of discrepancy or error in Tender notice, bid document and other document of Construction of Ward Office Buildings mentioned above reserves right to amend, correct at any time. Such amendment and correction shall be published in the national daily newspaper, notice board of the Chure Rural Municipality Office, Gharbheda, Kailali.
